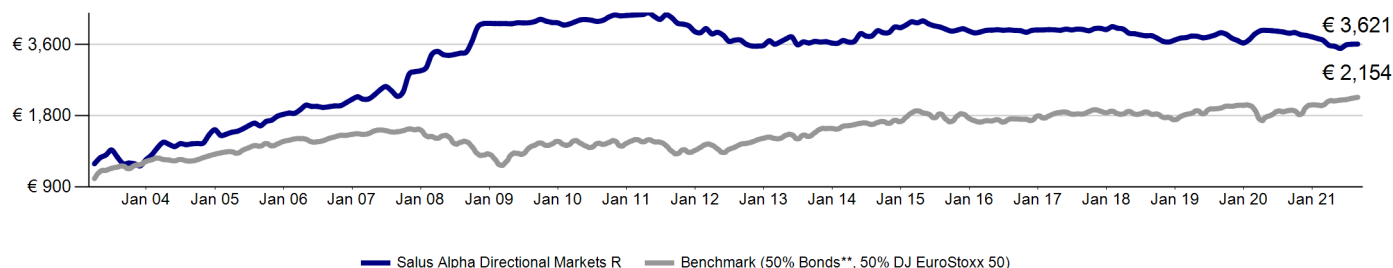
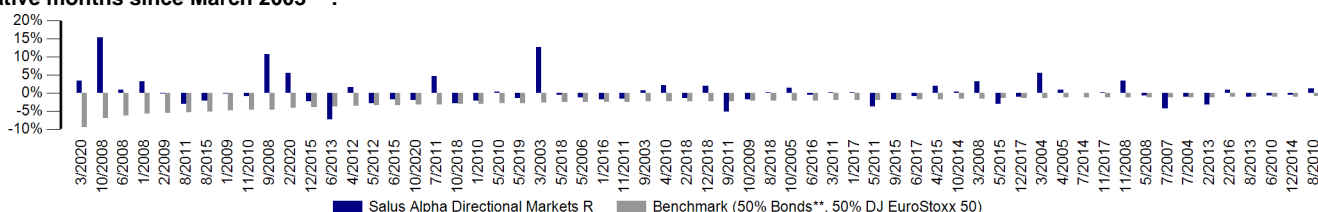


## Investment Approach

Salus Alpha Directional Markets R EUR is a sub-fund of Salus Alpha SICAV which targets competitive returns under consideration of capital preservation and liquidity of the fund's assets. To achieve its investment objective the Fund invests across the world in the most liquid markets. When implementing the Fund's strategy, the fund is positioned depending on the direction of the expected return (price forecast) and the quality of the price forecast. Low risk assets having a good forecast quality are weighted to achieve the target volatility level of the fund whilst high risk assets having a bad forecast quality are weighted less to achieve the target volatility level of the fund (Multi Asset Equal Risk).
